# REQUEST FOR PROPOSALS — RESEARCH STUDY ON LOCAL ORGANISATIONS WORKING DURING AND AFTER THE EARTHQUAKE HUMANITARIAN RESPONSE IN TÜRKIYE/SYRIA

## BACKGROUND

The Humanitarian Leadership Academy as part of Save the Children is one of the leading organisations providing humanitarian learning globally, supporting individuals and organisations to prepare for and respond to crises.

The HLA believes that to continually meet the changing needs of the sector and understand the ever-changing humanitarian landscape, it is vital to invest in research and learning. To this end, the HLA is seeking researchers involved in the humanitarian response to the earthquake in Türkiye/Syria to carry out a discreet research project, contributing to the understanding of the local humanitarian response in the region.

With this Terms of Reference, we seek to invite proposals from **researchers from or based in Türkiye (preferably Gaziantep)** for a rapid research (of the duration of five months in total) on the role of local organisations operating in the Türkiye/Syria earthquake response.

## 2 OBJECTIVES

This rapid research will focus on understanding the work of local organisations in operating during and after the humanitarian response to the earthquake in Türkiye/Syria. Through this research project, we seek to highlight the contribution of local organisations in this context, providing robust evidence on the scale and type of operations implemented by local humanitarian actors.

The research will focus on both formal organisations (such as local non-governmental organisations), and informal initiatives (e.g. volunteer and grassroots organisations, and other informal initiatives). During the inception period, the researchers will assess the feasibility of including informal initiatives into the study, as they may be harder to track and engage with.

Through the research, we seek not only to understand the scale of this contribution, but also to understand how INGOs, such as Save the Children/HLA, can provide tailored and meaningful support. This project will inform how the HLA, and more broadly Save the Children, can take up the mandate of powershift and localisation as part of the Engine 2 approach. It will serve as a basis for understanding the needs of these organisations and make sure the HLA can support them in the future.

The main objectives of this consultancy are as follows:

- To create a snapshot of local humanitarian organizations operating in the earthquake response
- To understand the operations of local humanitarian organisations, their needs and challenges
- To provide the HLA with recommendations on ways to support local humanitarian organizations involved in this specific response.

The research will be delivered by research consultants or research organisations from, or

based, in Türkiye (preferably Gaziantep). Preference will be given to local research consultants or organisations.

We are envisaging this research to be conducted by a team of one or two mid-level or senior research consultants, with potentially a member of the HLA Research & Evidence team in a senior role, depending on the make-up of the proposed team.

# 3 Research questions

#### Overarching research question:

 How have local organisations (including local NGOs, volunteers, grassroots organisation) evolved their support to local populations since the earthquake in 2023?

#### **Sub-questions:**

- a. How are local organisations understanding/addressing evolving needs of the populations, particularly those of women, youth, people with disabilities?
- b. How have they coordinated among themselves and with other actors during and after the response?
- c. How has funding changed between 23 and 24?
- d. How have the relationships with INGOs/international organisations changed over
- e. What are the future needs that need to be addressed?

The focus of the research will be on local NGOs, including small NGOs/volunteer and grassroots organisations, to address the gap in knowledge we have around this particular sector of the civil society.

## 4 METHODOLOGY

The research will adopt a mix-methods approach, including:

- 1) Desk research: brief analysis of available literature regarding women's role in other humanitarian crises and, more specifically, in this crisis. This will provide background and context to the subject matter.
- 2) In-depth interviews and focus group discussions: The interviews and focus group discussions will be conducted with local organisations to gather their experiences and perspectives. The qualitative data will gather deeper insights into the work of organizations operating in the sector.

The methodology will be further discussed in detail and designed during the inception period, taking into account a variety of factors.

# 5 Deliverables

It is expected that the research will produce the following deliverables:

- 1) Brief inception report, outlining refined research questions, methodology, timeline and outputs of the research.
- 2) Research report, synthetizing data from different sources and providing insights and recommendations.
- 3) Learning brief, distilling the main findings and recommendations of the research report, which can be used for public use and/or advocacy purposes if relevant.
- 4) Delivering presentations about the research to relevant stakeholders.

Translation costs (if applicable) of the deliverables will be covered by the HLA, but the **consultancy will be fully conducted in English and the reports will be written in English**. It is expected that research tools (eg. surveys, interview questions, etc.) are shared with the HLA team in English before implementing the research.

## 6 TIMELINE

It is expected that the research will start in August 2024 and end in December 2024.

# 7 QUALIFICATIONS AND REQUIREMENTS

Prospective consultants should meet the following criteria:

- 1. Demonstrated experience in conducting and delivering research in humanitarian settings, particularly in Türkiye/Syria
- 2. At least 5 years of experience in the humanitarian sector as researchers
- 3. Proven track record of conducting research with local organisations and community members, using participatory and gender-sensitive research methodologies
- 4. Fluency in written and spoken English, Turkish and Arabic
- 5. The team delivering the research **must be** based in the countries of research. Preference will be given to local researchers and/or organisations
- A proven track record of conducting research for reputable organisations in the humanitarian sector and in particular in conflict zones, with refugees and other vulnerable groups
- 7. Ideally have a strong network of local organisations working in the earthquake response to leverage contacts for research
- 8. Strong interpersonal and communication skills, cultural sensitivity with international teams
- 9. Ability to write concisely in English
- 10. Experience of working collaboratively with international organisations on multistakeholder projects
- 11. Availability and willingness to travel to conduct primary research if required

# **8** FEES AND REIMBURSEMENT

Selected consultants shall be compensated for their research services under this contract. Consultants shall submit a detailed budget, specifying the services rendered and the corresponding fees, after each completed research iteration.

Payment will be made promptly upon submission of deliverables and verification of the invoice and other required documentation. It is understood that the agreed fee shall remain fixed for the duration of the contract, subject to any mutually agreed-upon adjustments due to unforeseen circumstances or changes in the scope of work.

Responses will be assessed based on demonstrated ability of a prospective organisation's ability to meet the "Statement of Requirements / Objectives" and "Consultant Specification", and incorporating a value for money approach.

#### 10.2 CONFIDENTIALITY

Documentation in relation to this Request for Proposal and any proposals received by the HLA in response to it shall be treated as private and confidential save where the disclosure is required by law.

Suppliers shall not:

Release any information relating to the Request for Proposal and the proposal that they intend to make; other than with professional advisers who need to be consulted with regards to the preparation of the proposal;

Canvass directly or indirectly with any other bidder concerning the award of the contract or directly or indirectly obtain, or attempt to obtain information;

Canvass directly or indirectly with a member of SCUK or any other campaign coalition partners' staff or their trustees concerning the award of the contract or directly or indirectly obtain or attempt to obtain information from said individuals.

If a supplier does not observe paragraphs 4.2.1 and 4.2.2 above, SCUK will reject their proposal and may decide not to invite the agency to bid for future work.

## 10.3 Contract Award/Acceptance of Proposal
